Change of RSL PFH District Constitution and By Laws -

Motion to the District Council Meeting Refer to approval of name change of motion 039.22 at the District Council meeting in Clermont on the 19th November 2022 08.23

MOTION 1. It is resolved that the RSL Pioneer – Fitzroy – Highlands District Branch Inc. constitution changes its name to the RSL Central QLD District Branch Inc. constitution and the changes will be reflected in the constitution

2. It is resolved that the RSL Pioneer – Fitzroy – Highlands District Branch Inc. By Laws change its name to the RSL Central QLD District Branch Inc. and the changes will be reflected in the By Laws.

At the District Council Meeting held on the 25th March 2023 both motions were voted in unanimously and furthermore they were forwarded to RSL State Branch and approved by The State Council of District Presidents

Other Matters

The RSL Board approved the constitution on the 4th May 2023.

The District Secretary and myself will start implementing the name change and the administrative process ASAP. The State Branch has been informed that the official time frame for these changes will take effect from the 1 July 2023.

On the 10 May, a Teams meeting was held with Christian Pedersen, Lynette Phillips & myself to discuss the renovations to Sydney Street Property, Mackay.

The current lease will finish in August 2023 at which time renovations to the interior of the building will commence ASAP.

It is planned to create two offices instead of the current configuration as it will be more suitable for the current market.

A draft plan has been provided to the executive for comment.

The draft plan can be modified to relocate the district office into this building in the future if deemed appropriate.

State Board and Related Matters

Board Sub Committees.

In light of the changes to the Board and the establishment of the State Council of District Presidents (SCDP) the structure of our sub committees was discussed.

The principles of ensuring we meet our governance requirements, that we best use our available skills, that at least one Board Director be on each subcommittee, and that we have sufficient sub committees and committee members to meet our requirements but no more, were used to guide our discussion and decision making.

The key changes include:

- The transfer of Award and Constitutional functions from the Governance, Constitution and Awards (GC&A) Sub Committee to the SCDP.
- The transfer of the Governance function, and clarified to be Board Governance, to the Nominations and Remuneration Committee.
- The winding up of the GC&A Sub Committee. The Committees will now be: State Council of District Presidents Chair, Les Nash
- Audit and Risk Chair, Barry Vains
- Nomination, Remuneration and Board Governance Chair, Chris Hamilton
- Investment Chair, Adam Walk

A Revised Committee structure will be published on Skip in the coming weeks.

Dental & Allied Health Program

Sub Branches need to ensure they familiarize themselves with this documentation before an application is made. Sub Branches are encouraged to come up with worthy projects and apply for funding.

The new application forms should be available from Lynette Phillips (District Secretary) in June; however, this is subject to State Branch formalizing the process.


