- **2.** All RSL membership application to be forwarded to the District Secretary after completed and the district will then forward them to membership for processing.
- **3.** In conjunction with the State Secretary and the SCDP's By-Law 7 is currently under review.

One of the main changes which will come into effect when completed is the statute of limitations will be reduced from three years to one year.

- **4.** The State Secretary in conjunction with the SCDP's is reviewing 5.2 of the constitution which deals with the purchase, sale, leasing of property as the general intent is to simplify the process.
- **5.** All Life Memberships Applications have to be signed and a comment included by the President of the Sub Branch as well as the badge number before it is submitted to the District Secretary.
- **6.** There has been further discussion on the Members Value Proposition and it may be included in the 2025 State Congress for consideration, furthermore any motions for the State Congress have to be forwarded to the District Secretary for the SCDP for their information.
- **7.** The SCDP in conjunction with Bill Kernoczy (Head of League Services, Legal) are reviewing the COF application as the SCDP have some concerns regarding restricted items on the application.
- **8.** RSL Sarina reformation has been delayed by the liquidators as they are currently following up on outstanding superannuation entitlements for previous employees.

Sub Branch financials **MUST BE PROVIDED** as well as **QUOTES** for the functions, trips away and any other event, before any application can be considered.

Sub-Branches need to ensure they familiarize themselves with this documentation before an application is made. Sub-Branches are encouraged to come up with worthy projects and apply for funding.

NOTE: COF applications will NOT be paid retrospectively. Quotes have to be provided on the application otherwise the sub branch will have to meet the out-of-pocket expenses.

RSL State Board Talking Points

This month's Board meeting took place at a new location, as we toured two RSL Art Union properties on the Gold Coast and received a briefing on the operational aspects of the Art Union. It provided invaluable insights into the various components and dedicated individuals that drive the success of the RSL Art Union.

Below are the key points from our Board meeting of 19 September 2024:

Veteran Support

RSL Queensland invests significantly in national programs and services to assist veterans and their families across Australia, and the Board discussed how we can continue to deliver this support and effectively reach the veteran community. RSL Queensland Property Portfolio

As you may recall, I have discussed the 'Capital Management Framework' several times. This framework aims to provide a long-term planning perspective, enabling our organisation to effectively plan and invest in services and programs. Recognising the critical role of our property portfolio in supporting our mission, we developed a policy to ensure its strategic, efficient, and responsible management.

Currently, we are conducting a baseline evaluation of all properties in our portfolio. While this may lead to changes in our property holdings in the future, we will always have clear strategies and plans in place to minimise any impact from these changes.

Annual Board & Committee Evaluation Process

Board and Committee evaluations are essential for strong governance, allowing the Board to pinpoint strengths, weaknesses, and gaps in the governance framework. Committed to ongoing improvement, the Board has approved a 'Board & Committee Evaluation Guideline' that enhances the existing process and offers a flexible format adaptable to both the Board and each Committee.

Sub Branch Dealings and constitution amendments

As you may know, clause 5.2 requires Sub Branches to obtain prior written consent from RSL Queensland before engaging in certain transactions, such as property dealings.

We are always seeking ways to streamline this process for Sub Branches. In response to a suggestion from the Stanthorpe Sub Branch, the Board approved amendments to the Procedure: Request for consent to dealings under clause 5.2, allowing for pre-approval of property sales and/or purchases by Districts and Sub Branches. We understand that property transactions often require urgency, and waiting for consent can be challenging for Districts or Sub Branches. This amendment aims to address that concern.

We hope this change will also decrease instances where Sub Branches seek consent after completing a transaction. Entering into a property transaction without obtaining RSL Queensland's

consent puts a Sub Branch in breach of its Constitution, and the Board is of the view that it is not appropriate to grant consent retrospectively.

Sub Branch Constitution amendments

We are beginning to see many Sub Branches update their Constitutions to align with the 2024 Model Sub Branch Constitution. While most amendments can be approved by the State Council of District Presidents, those that exceed the Council's authority are submitted to the Board for approval. These typically involve changes that are not in line with the 2024 Model Sub Branch Constitution.

It is important to note that an amendment diverging from the 2024 Model Sub Branch Constitution does not automatically disqualify it from approval. However, the Board is of the view that it is not appropriate to approve changes, especially changes to the Objects clause, that are inconsistent with the Objects of the League.
